AIR TRANSPORTATION

American, United and Air Canada are the official air carriers for the Fourteen All-American Council, and offer substantial savings for Council participants. Travel dates are from July 15-25, 2005.

United Airlines:

United is offering Council members a 5% *discount* on any published or promotional fare for qualifying passengers. A 10% *discount* on any published economy fare for qualifying passengers booked 60-days in advance. (May 15, 2005.) *These discounts are not valid on internet booking or fares.*

American Airlines:

American is offering Council members a 5% *discount* on any published or promotional fare for qualifying passengers. American is also providing ZONE FARES. These fares provide the traveler that is not staying over a Saturday night a lower fare than published rates. These Zone Fares are valid on American flights only – not code shared flights. **Refer to: 14th AAC Council**

Air Canada is providing members with the following discounts:

Canada/USA, USA/Canada & Intra-Canada travel: 10% off Executive (*J* or *Business class*) or Freedom type fares (*Y* or *economy type fares*)

Intra-Canada travel only: 35% off Freedom type fares booked in "B" inventory (BCF)

- *All of the above is eligible for additional 5% discount if tickets are purchased 30 days prior to departure.*

Air Canada is also providing members with ZONE FARES. These fares provide the traveler with a lower fare than published rates. These Zone Fares are valid on Air Canada and their code shared flights. **Refer to: Convention number: CV054113**
