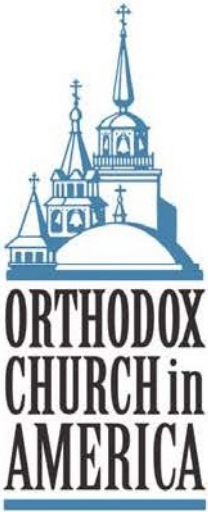
EPISCOPAL CHANGES
