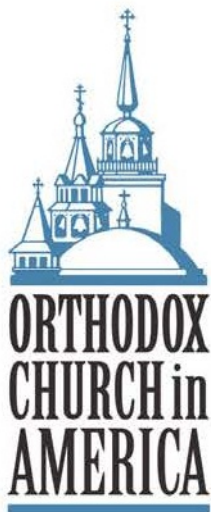
BEINER, Deacon Phillip is attached at Three Hierarchs Chapel, Yonkers, NY, effective December 22, 2019. (Stavropegial)
