RECEPTIONS

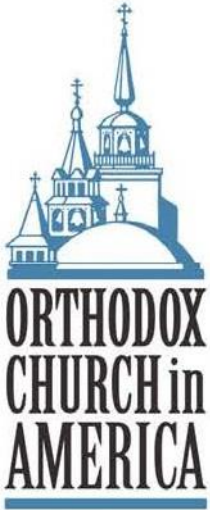
